The Energy Facilities Siting Board will hold a public comment hearing on **Monday, September 24, 2018 at 7:00 p.m.** at the Ashland High School auditorium at 65 East Union Street, Ashland, Massachusetts, regarding a proposed natural gas pipeline replacement project, as described below. The attached legal notice describes the potential routes of a proposed natural gas pipeline replacement project in the Towns of Hopkinton and Ashland and the opportunities for public participation in the review process. **Please read this notice carefully.**

NSTAR Gas Company d/b/a Eversource Energy (“Eversource” or “Company”) filed a petition (“Petition”) with the Energy Facilities Siting Board (the “Siting Board”) for approval to construct a 12 inch diameter natural gas pipeline to replace an existing 6 inch diameter natural gas pipeline located between the Wilson Street Gate Station in Hopkinton and the Pond Street Gate Station in Ashland (“Project”). The Company proposes construction to replace the existing pipeline in segments over five years. Eversource states that the Project is needed to alleviate an existing pressure drop that limits the flexibility and reliability of the gas supplied by the Company to customers in the Greater Framingham area. The Siting Board will review the proposed Project including the routes outlined in the attached legal notice and determine whether the Project will provide a reliable energy supply with a minimum impact on the environment at the lowest cost pursuant to G.L. c. 164, §§ 69H, 69J. The attached legal notice describes the potential routes that the Company proposes for the Project and includes a map of those routes. Select “Dockets/Filings” then “Docket by Number”, then enter “EFSB18-02” (no spaces).

The Siting Board is a state agency that will determine whether the Company’s Project should be approved. At the public comment hearing, the Company will provide information on the Project and the Siting Board will receive comments from members of the community. The public comment hearing is an important opportunity for the community to learn about the Company’s Project and for the Siting Board to hear questions and concerns from the community; anyone with an interest in the Company’s Project is encouraged to attend.

Individuals and groups affected by the Company’s petition who wish to be involved in the Siting Board’s review process may request to participate as either intervenors or limited participants. Such requests must meet the criteria outlined in the attached legal notice. **The deadline to make such a request is 5:00 p.m. on Monday, October 15, 2018.** The process for making a request to participate is explained in the legal notice. Questions concerning participation also will be answered at the public comment hearing.

Notice is hereby given that on June 11, 2018, pursuant to G.L. c. 164, § 69J, NSTAR Gas Company d/b/a Eversource Energy (“Eversource” or the “Company”), located at 247 Station Drive, Westwood, Massachusetts 02090, filed a petition with the Energy Facilities Siting Board (the “Siting Board”) for approval to construct a natural gas pipeline replacement in the Towns of Hopkinton and Ashland, Massachusetts. Eversource is proposing the Hopkinton-Ashland Transfer Line Replacement Project (the “Project”) to replace the 3.71 miles of existing 6-inch diameter steel natural gas pipe between the Wilson Street Gate Station in Hopkinton and the Pond Street Gate Station in Ashland (“Transfer Line”) with new 12-inch diameter pipe. The Company proposes to replace pipeline in segments over five years. Eversource states that the Project is needed to alleviate an existing pressure drop that limits the flexibility and reliability of gas supply to its customers in the Greater Framingham area.

***The Siting Board will conduct a public comment hearing to receive public comment on the proposed Project on Monday, September 24, 2018, beginning at 7:00 p.m. at the Ashland High School auditorium at 65 East Union Street, Ashland, MA 01721. At the public comment hearing, the Company will present an overview of the proposed Project. Public officials and the public will then have an opportunity to ask questions and make comments about the Project. The public comment hearing will be recorded by a court reporter. The Siting Board will also accept written comments on the proposed Project. *Written comments may be filed with the Siting Board as described in the section entitled Comments, Intervention and Participation of this Notice through Monday, October 15, 2018.****

**Siting Board Jurisdiction**

The Siting Board will review the Company’s filing to determine whether the proposed Project will provide a reliable energy supply with a minimum impact on the environment at the lowest possible cost pursuant to G.L. c. 164, §§ 69H, 69J.

**Preferred Route for the Pipeline Replacement**

Based on the Company’s routing and alternatives analysis, Eversource has identified a Preferred Route for the proposed gas pipeline that uses an existing pipeline easement, in which the existing 6-inch diameter Transfer Line is currently located. The Company’s Preferred Route would replace the Transfer Line within the existing easement beginning approximately 2,200 feet east of the Wilson Street Gate Station, on a property located between Wilson Street and Legacy Farms Road North in Hopkinton. The easement continues to the east across two large

undeveloped parcels of land. The easement crosses the southern edge of the pond located behind the Liberty Mutual facility on Frankland Road. Upon reaching Cross Street, the easement continues east across residential parcels with frontage on Frankland Road and across the Brook Hollow property owned by the Hopkinton Area Land Trust before crossing into Ashland. Upon entering the Town of Ashland, the easement crosses residential parcels with frontage on Hardwick Road, Pennock Road, Winesap Way, and Indian Spring Road before reaching West Union Street (Route 135). The easement continues to the east across residential parcels with frontage on West Union Street before entering Ashland State Park. The easement crosses through a section of the park, then crosses residential parcels with frontage on Metropolitan Avenue before re-entering Ashland State Park. The easement crosses Cold Spring Brook north of the Ashland Reservoir dam and spillway, exits Ashland State Park, and continues east across residential properties with frontage on Warren Road before reaching Chestnut Street. East of Chestnut Street, the easement continues across a residential property with frontage on Chestnut Street before crossing a parking lot associated with the Chestnut Place Apartment Homes complex on Joanne Drive. East of Joanne Drive, the easement passes through residential parcels with frontage on Prospect Street, Stage Coach Drive, Wayside Lane, Brimstone Way, and Carriage House Path. The easement also crosses open space property designated as Ledgemere Farms Conservation Restriction, controlled by the Great Bend Farm Trust. The Preferred Route terminates at Cedar Street. Approximately 1.14 miles of the Preferred Route is located in Hopkinton and 2.57 miles in Ashland.

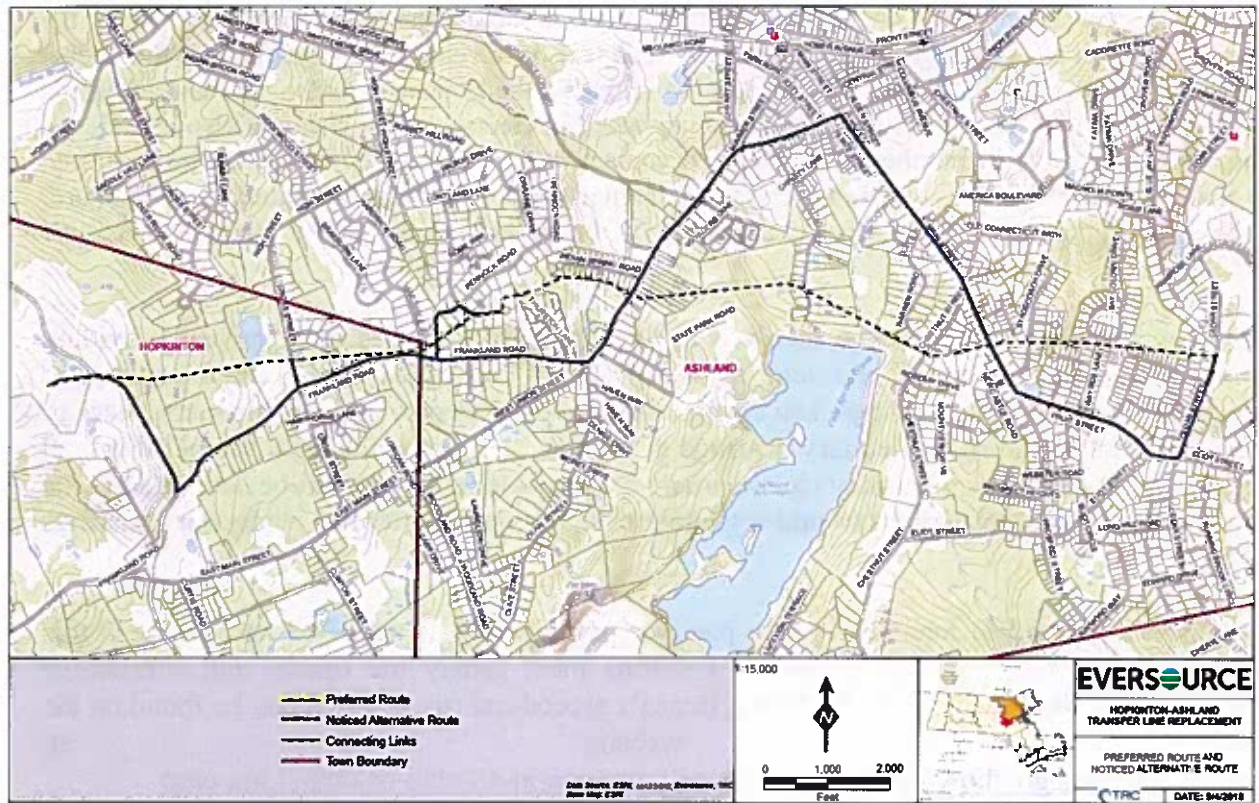
### **Noticed Alternative Route for the Pipeline Replacement**

In addition to the Preferred Route described above, the Company also identified a Noticed Alternative Route for the proposed pipeline replacement. The Noticed Alternative Route represents an in-street alignment for the proposed replacement pipeline and would start at the same location as the Preferred Route, and would follow the existing Transfer Line easement for approximately 845 feet. From that point, the Noticed Alternative Route follows existing roadways. It heads south on Legacy Farms Road North, then east on Frankland Road, crossing into Ashland. The Noticed Alternative Route continues east on Frankland Road, then northeast on West Union Street (Route 135) and Union Street. The route turns southeast on Main Street and continues on Prospect Street. It turns east on Fruit Street and continues east on Eliot Street, then north on Cedar Street to reach the eastern terminus of the Preferred Route at the Transfer Line easement at Cedar Street. The total length of the Project using the Noticed Alternative Route is approximately 4.99 miles. In the event that the Preferred Route and its Variations are rejected, the Company seeks approval to construct the Project on the Noticed Alternative Route.

### **Route Combinations**

The Company identified two points where the Preferred Route and the Noticed Alternative Route intersect, and two short links that could be used to connect the two routes where they approach each other. One short connecting link is an approximately 450-foot section of Cross Street, in Hopkinton, between the Transfer Line easement and Frankland Road. The second short connecting link is approximately 1,300-feet long; it begins at the intersection of Frankland Road and Pennock Road, follows Pennock Road north across the Transfer Line easement, then turns east on Winesap Way where it reconnects with the Preferred Route. Each intersecting point and

link offers an opportunity for the route to switch between the Preferred Route (in the existing easement) and the Noticed Alternative Route (in streets). A final approved route could include both segments of the Preferred Route and the Noticed Alternative Route. In the Petition, three of these segments are described by the Company as “variations.”



The location, layout, dimensions and configuration of the Project are shown on maps and plans included in the Company’s Petition.

### **Comments, Intervention and Participation**

The text of the email must specify: (1) the docket number of the proceeding (EFSB 18-02); (2) the name of the person or company submitting the filing; and (3) a brief descriptive title of the document. The electronic filing should also include the name, title and telephone number of a person to contact in the event of questions about the filing. The Siting Board encourages electronic filings and related documents to be submitted in PDF, Word, or Excel, as appropriate. All written comments will be posted on the Siting Board's electronic fileroom.

Persons or groups who wish to be involved in the Siting Board proceeding beyond providing comments may seek either to intervene as a party or to participate as a limited participant. Intervention as a party allows the person or organization to participate in the evidentiary phase of this proceeding, including evidentiary hearings in Boston, and grants the right to appeal a final decision. A limited participant may receive many of the documents that will be submitted to the Siting Board and present written or oral argument to the Siting Board after evidentiary hearings conclude.

Any person interested in intervening as a party or participating as a limited participant in this proceeding must file a written petition. Petitions must satisfy the timing and substantive requirements of 980 C.M.R. 1.05, the Siting Board's procedural rules, which can be found on the Board's [website](https://www.mass.gov/how-to/file-a-petition-to-intervene-in-an-efsb-or-dpu-siting-case) at: <https://www.mass.gov/how-to/file-a-petition-to-intervene-in-an-efsb-or-dpu-siting-case>

**A petition must be filed in hard copy with the Presiding Officer, Donna C. Sharkey, Energy Facilities Siting Board, One South Station, Boston, Massachusetts, 02110, no later than the close of business (5:00 p.m.) on October 15, 2018.**

The petition must also be filed with the Siting Board in electronic format by e-mail attachment to [dpu.efiling@mass.gov](mailto:dpu.efiling@mass.gov). The text of the email must specify: (1) the docket number of the proceeding (EFSB 18-02); (2) the name of the person or entity submitting the filing; and (3) a brief description of the document. The electronic filing should also include the name, title and telephone number of a person to contact in the event of questions about the filing.
